

Parent & Family Engagement Policy

1. Palm River School shall jointly develop with, and distribute to, parents and family members of participating children a written parent and family engagement policy, agreed on by such parents, that shall describe the means for carrying out the requirements of ESSA Section 1116 subsections (c) through (f).

The policy will be available in both print and electronic formats with a copy posted on the school website. Copies of the policy will be available in both English and Spanish or other languages represented by the families in the school community.

2. Palm River School shall convene an annual meeting, at a convenient time, to which all parents of participating children shall be invited and encouraged to attend, to inform parents of their school's participation under this part and to explain the requirements of this part, and the right of the parents to be involved; Section 1116(c)(1).

The Annual Title I Meetings will be held in the fall and will be repeated as necessary to ensure meetings are convened at a convenient time/day to meet parents' work schedules. Advance notice of meetings will be sent to parents in the form of emails, social media posting, or an information flyer. The administrator will be responsible for conducting the meeting.

3. Palm River School shall offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, childcare, or home visits, as such services relate to parental involvement (Section 1116 (c)(2)).

Flexible meetings will be scheduled with the option for virtual or face-to-face meeting formats and will provide a variety of days/times for meetings with parents. The school will offer assistance to parents who request and need transportation, childcare, or home visits when necessary for parents to attend or participate in meetings.

The above data are being analysed and will be repeated as necessary if any positive results are obtained.

4. Palm River School shall involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under this part, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan under section 1114(b) except that if a school has in place a process for involving parents in the joint planning and design of the school's programs, the school may use that process, if such process includes an adequate representation of parents of participating children (Section 1116 (c)(3)).

Parents will have the opportunity to provide input and develop the school's PFE program and activities during scheduled parent meetings throughout the year. The PFE policy will be reviewed and revised annually during the Annual Title I Meeting and/or the Title I Parent & Family Engagement Evaluation. Parents from each demographic group will be invited and encouraged to participate in the development of the annual Schoolwide Plan.

5. Palm River School shall provide parents of participating children — (A) timely information about programs under this part; (B) a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging State academic standards; and (C) if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible (Section 1116 (c)(4)).

Parents are informed about the PFE program and activities in a variety of ways to include one or more of the following: emails, automated phone messages, information flyer, newsletter, website, social media, banners, school marquee, and/or in-person invitation. Examples of PFE activities during the school include:

updating w/ events

Information about the curriculum and assessments will be provided to parents during the Annual Title I Meeting, Parent/Teacher Conferences, and the Federal School Report Card.

6. If the schoolwide program plan under section 1114(b) is not satisfactory to the parents of participating children, parents are encouraged to submit any comments on the plan when the school makes the plan available to the local educational agency (Section 1116 (c)(5)).

Parents are invited and encouraged to participate in the development of the Schoolwide Plan. A copy of the plan will be provided to parents on request and/or will be posted on the website for review by parents. Parents can share their comments or questions about the plan with an administrator.

7. To ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, Palm River School shall provide assistance to parents of children served by the school, as appropriate, in understanding such topics as the challenging State academic standards, State and local academic assessments, the requirements of this part, and how to monitor a child's progress and work with educators to improve the achievement of their children (Section 1116 (e)(1)). Resources and assistance for parents to help their

parents will be provided during the Annual Title I Meeting, Parent/Teacher Conferences, and the Federal School Report Card.

8. All staff on the Title I campus will attend an annual training on the Value & Utility of Working with Parents. Parents will be encouraged to provide their input into the information for the training.


