# THE HOUSING CHOICE VOUCHER PROGRAM (SECTION 8) WAITLIST WILL OPEN FOR 5 DAYS ONLY OCTOBER 4<sup>TH</sup> – OCTOBER 8<sup>TH</sup> 2021

#### Overview:

The Department of Housing and Urban Development's regulations require Public Housing Agencies to provide public notice by publication in a local newspaper of general circulation and in minority media and other suitable means in accordance with the administrative plan and HUD's fair housing requirements.

The opportunity to apply for the Tampa Housing Authority's (THA) Housing Choice Voucher Program (Section 8) will be open October 4<sup>th</sup> at 8 am and will close October 8<sup>th</sup> at 5 pm. The application will be made available online and will only be accepted during the specified dates. At the close of the application acceptance period, only 3,000 applicants will be selected through a lottery system and placed on the waitlist in the order selected during the lottery process. The selection is NOT based on date or time of the application. All other applicants will be rejected and will be notified via email. If the application is selected, an email will be sent notifying the applicant of the acceptance and placement on the HCV (Section 8) waitlist. Inquiries will not be accepted and or answered related to when the application will be processed for rental assistance.

### There is a two-step process to make application:

- 1. First create a portal registration
- 2. Then make application in the portal when the application period is open.
