# FL Model Threat Management 2025 Summer Procedures

**SUMMER School Based Threat Management Teams (SBTMT)** 

If you are hosting summer learning on-site, please identify staff members who are trained in the Florida Model (i.e. Chair, Vice Chair, Administrator, Mental Health, Instructional).

• For Mental Health support with Threat Management Cases this summer, please refer to page 1 of this document.

*Note: If your campus only has one administrator – the principal must act as the Chair.* 

## **SUMMER THREAT MANAGEMENT**

All Florida Model processes will remain the same as the traditional school year with the following exceptions:

- Schools hosting summer learning will be responsible for all Threat Management cases that occur on their respective campuses, *even if the student of concern is from another school.*
- The school of origin for the student should be notified of any Threat Management cases that occur over the summer.
- Documentation must be completed in EdPlan within State Required Timelines.
  - o If you have any challenges accessing EdPlan or individual students, please contact 813-273-7136.
  - Same acknowledgement process will apply over the summer.

#### **MEETINGS**

- Monthly SBTMT meetings are not required for June and July. Teams will reconvene in August.
- The District Threat Management Team (DTMT) will continue to meet on a weekly or as needed basis during June and July.

### **SUMMER MONITORING: Student Support Management Plan (SSMP)**

- If the originating school's SBTMT amended the student's SSMP for the summer, those changes *must be documented* on the SSMP in EdPlan.
- When the originating SBTMT has determined that a student of concern must be monitored over the summer, this must be done with the same frequency and interventions identified in the most recent SSMP.
  - The frequency of contact is not a one size fits all.
    - Consider the totality of circumstances.
    - Consider the incident that warranted the threat assessment and most appropriate interventions.
    - Higher levels of concern may warrant more frequent contact.

#### Some recommended methods of summer monitoring:

- Phone, virtual or in-person meetings with student of concern or parent
- Collaborating with local law enforcement agencies or school security

#### TRAINING

- Florida Model training schedule for the 25/26 school year will be released in July.
- Florida Model state-required refresher training is mandatory for *all SBTMT team members* and alternates.
  - o Information on the refresher training will be available in July.
  - o Refresher training must be completed within the first 30 calendar days of the start of school.
