- The TABE test is a state certified test. This test is a 3-day test.
- **MUST** have **ACCEPTABLE** photo ID
- Cost of TABE test is \$10. (Money order ONLY)
- First day of testing- Approx. 1 ½ – 2 hours – **MUST BE HERE AT 8:30 AM.**
- Second day of testing- Approx. 2- 2 ½ hours- **MUST BE HERE AT 9:00 AM.**
- Third day of testing- Approx. 3 hours- **MUST BE HERE AT 9:00 AM.**

Information Required to Complete Hillsborough County Social Services Application

Applications available at the locations above for Pick Up.

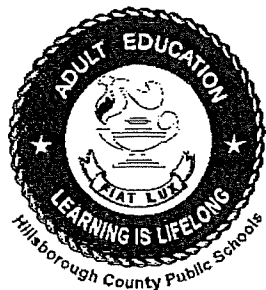
Hillsborough County Social Services receives applications by household. You must live within the boundaries of Hillsborough County. For every member residing at the address, we will need the following documentation:

- Two documents noting household physical address (no post office boxes) within Hillsborough County.
- Persons with a Social Security number please provide proof however all others may still apply.
- Florida identification card, Florida Driver's License, or other State or Country issued identification card or Passport accepted that is not expired.
- Proof of Identification required for minor children such as Birth Certificate, Shot Record, or Passport.
- Department of Children and Families benefit letter indicating amount of benefits the family receives and the recipient names.
- Proof of all income received in the household for the last 30 days. Ex. Wages, SSI/SSD or Child Support.
- Additional documentation may be required.

Counselors are available to assist in educational and career advising.
