Our students and teachers have worked hard academically to achieve this recognition and should be celebrated for their accomplishments.

Being a Gryphon going on 20 years, I am extremely proud to represent the Sickles family as the new principal of this amazing school and community. Starting as a first-year teacher in the English department, I also served as the AVID Coordinator, Assistant Principal for Student Affairs, and most recently the Assistant Principal for Curriculum at Sickles. I am excited and honored to now serve as the principal to continue the initiatives and academic supports that make this school so successful.

We are excited to continue this high academic tradition this school year with our students and staff and look forward to seeing all our students back on campus on the first day of school, Wednesday, August 10, at 8:25 AM. As always, we plan to offer a strong academic program for all our students through challenging and engaging learning experiences. We also focus on the social and emotional well-being of all our students by offering supports through our Student Services office. Finally, we are conscious of the safety and security of all our staff and students. For this reason, please be sure to follow the school protocols for entering campus and signing your students in or out of school.

The Sickles Open House for all students is on Friday, August 5. From 10:30 AM to 12:30 PM sophomores, juniors, and seniors will report to homeroom to receive their class schedules. Students and parents can then walk the schedule to meet the teachers at their own pace. There is no set schedule to follow. Seniors only may purchase parking decals and lockers during this time in the cafeteria. From 3:30 PM to 5:30 PM, freshmen may pick up their class schedules in homeroom and walk the schedule to meet their teachers. Homeroom rosters are posted on the Sickles website, Canvas, and throughout the school.

During Open House, our PTSA will have memberships and apparel available for purchase. Yearbooks will also be available for a discounted price of \$70. Yearbook prices do increase throughout the year. All sales will be located in the cafeteria.

The first day of school for students is Wednesday, August 10, 2022. Students will report to homeroom first at 8:25 am. Students should be sure to bring their homeroom location with them on the first day of school. This information is on their schedule and will be available on Canvas and the Sickles website [Sickles High / Homepage \(hillsboroughschools.org\)](http://Sickles High / Homepage (hillsboroughschools.org)) Students will receive OFFICIAL schedules during homeroom on the first day. Emergency cards will be sent home the first day of school. It is critical that these cards are updated and returned with correct contact information. *Emergency cards must be updated and on file for students to sign out of school.*

Take some time to review the newsletter as there is a great deal of information related to curriculum, student services, athletics, and PTSA. You will also find useful information from the Office of Student Affairs regarding attendance, parking, lockers, buses, and expectations for student behavior.

Our student bell schedule to start and end the day is 8:30 AM to 3:25 PM Tuesday through Friday and 8:30 AM to 2:25 PM on Mondays. Adult supervision will be in place beginning at 8:00 AM. Please do not drop your student off prior to 8:00 AM. Traffic is always congested on the first day of school, so be sure to allow for extra travel time. The faculty, staff, and I are looking forward to seeing our students on August 10th!

What You Should Know About Senior High Athletic Eligibility

Academic Requirements

If you are in the 11th grade or 12th grade, you must have a cumulative 2.0 grade point average on a 4.0 unweighted scale in all courses taken through the end of the previous semester. If you are in the 9th grade or 10th grade, you must have a cumulative 2.0 grade point average on a 4.0 unweighted scale in all courses taken through the end of the previous semester; OR you must have earned a 2.0 grade point average on a 4.0 unweighted scale in the courses taken in the previous semester alone, provided you sign an academic performance contract (FHSAA form EL5) with your school and attend summer school as necessary. (Article 9.4, FHSAA Handbook, Bylaws and Policies)

Ninth Grade Eligibility

A student shall be eligible during the first semester of his/her ninth-grade year provided that it is the student's first entry into the ninth grade and he/she was regularly promoted from the eighth grade the immediately preceding year.

Residence

A student will be eligible at the first school in which he/she enrolls, or participates in an athletic practice, at the beginning of each school year. The student will be eligible in his/her first school of choice each year as long as the student remains enrolled in that school (Florida Law 97-53). Additionally, home school students who are registered through Hillsborough County Public Schools and charter school students who are enrolled in a Hillsborough County registered charter school are eligible for athletic participation at their school of residence.

Transfers

Per School Board Policy 2431.01, student-athletes who transfer are allowed to immediately participate in interscholastic athletics for their new school as long as they are enrolled prior to the start of a specific sport's season. Student-athletes that participate in a sport at their previous school during the same school year may not participate in the same sport unless they meet one of the following criteria:

- 1) Dependent children of active duty military personnel whose move resulted from military orders.
- 2) Children who have been relocated due to a foster care placement in a different school zone.
- 3) Children who move due to a court-ordered change in custody due to separation or divorce, or the serious illness or death of a custodial parent.
- 4) Authorized good cause established in this policy.

Age

Students reaching the age of 19 before July 1st will be ineligible to participate in interscholastic athletics for that school year and beyond.

Limit of Eligibility

A student shall be eligible for no more than four (4) consecutive academic years upon first entrance to ninth grade as defined by the pupil progression plan of the school in which the student is enrolled. A student who does not attend school, repeats any grade, is declared ineligible to participate, or otherwise fails to exercise the opportunity to participate for any reason for any length of time during this four-year period shall not be entitled to any additional period of eligibility.

Second semester 2022-2023	9 th and 10 th grade	Must have a cumulative 2.0 grade point average on a 4.0 unweighted scale in all courses taken through the end of the previous semester; OR must have earned a 2.0 grade point average on a 4.0 unweighted scale in the courses taken in the previous semester alone, provided he or she signed an academic performance contract with his or her school and attended summer school as necessary.
	11 th and 12 th grades	Must have a cumulative 2.0 grade point average on a 4.0 unweighted scale in all courses taken through the end of the previous semester
<p>A student shall be eligible for no more than four (4) consecutive academic years upon first successful completion of the eighth (8th) grade as defined by the pupil progression plan of the school in which the student is enrolled. Four years from the date he or she first successfully completes the eighth grade, he or she shall become ineligible for further interscholastic athletic competition. A student who does not attend school, repeats any grade, is declared ineligible to participate, or otherwise fails to exercise the opportunity to participate for any reason for any length of time during this four-year period shall not be entitled to any additional period of eligibility. Original school records shall be submitted to the Commissioner in the event of conflicting information as to the date of first successful completion of the eighth grade. (Article 9.5 FHSAA Handbook, Bylaws and Policies)</p>		
<p>Note 1: A grading period is defined as one semester. A semester is defined as one half of a school year (approximately 18 school weeks or 90 school days). This definition is applicable to all schools regardless of the type of class scheduling format used (i.e. block, traditional, etc.)</p>

Dear Sickles families,

Canvas is the best way to check your learner's progress, communicate with teachers and view assignments. See below for tips on navigating the program.

IF YOU NEED TO MAKE A CANVAS PARENT ACCOUNT

1. Go to HillsboroucanbvaghSchools.org
2. Hover over the Parents tab and select Canvas in the center menu3. On the top right, go to "Canvas for HCPS Parents" and register

NOTE: It will take until the next day to have access to your parent Canvas account, but you can view grades on your student's account

VIEWING GRADES ON PARENT OR STUDENT ACCOUNTS -- COMPUTER

1. Click on the "Dashboard," in the icons on the far left
2. Go to bottom right on screen and click "View Grades" -- this will show you current averages for all classes
3. Back on the Dashboard, you can click on any course and then select "Grades." You will then see grades for each assignment and an average at the bottom of the page.

VIEWING GRADES ON PARENT OR STUDENT ACCOUNTS -- PHONE

1. On the top left of each class icon, you should see a course average. If not, click on the menu in the top left and select "Show Grades."
2. For details on any course, click on the course icon and then select "Grades." You will then see grades for each assignment and an average at the bottom of the page.

NOTES

1. Note: During the second and fourth quarters, you will need to filter the grades to specifically show Q2 and Q4 grades.
2. It usually takes a day or two for a student to roll into new classes after schedule changes are made.
3. Parent communication is so important, so please don't hesitate to contact the school if we can assist you with navigating Canvas.

Please review the Student Affairs guidelines provided in this newsletter and the student handbook that will be available electronically during the first few days of school. Being aware of the school rules and procedures will increase the chances of having a successful school year.

1. VISITORS FOR STUDENTS AND/OR STAFF (HCPS Policy 9150, 9160)

Visitors must have prior approval from a staff member at least 24 hours prior to visitation on campus. Administration will determine whether meetings can be held virtually. Meetings with administration should be scheduled prior to visiting the campus.

Visitors to Sickles High School (including those making deliveries) must sign in with the receptionist in the main office. Photo identification is required. Any individual considered a non-student must obtain administrative clearance prior to entering the building. **Any person on campus without a visitors pass will be subject to a trespassing violation and possible arrest.**

2. ABSENCES

- a. All absences must be excused by a parent / guardian (via parent phone call or parent visit). **ONLY DOCTOR'S NOTES WILL BE ACCEPTED WITHOUT A PARENT PHONE CALL.**
- b. It is the student's responsibility to ensure accurate attendance. Students must have their parent/guardian call the attendance line within three days of their absence. If a parent does not call the attendance line within this time period, the absence will be unexcused. Absences cannot be changed after the third day.
- c. **All parents whose child is absent- excused or unexcused -will receive a courtesy call and/or email from the district office at approximately 9:30am indicating their child is absent.**

3. PRE-ARRANGED ABSENCES

Any student who knows he/she will be absent from school for a valid reason other than illness should report to the attendance office located in Student Affairs at least three days in advance of the absence for a "Prearranged Absence Form" that will be signed by all his/her teachers and his/her assistant principal. This includes all college visitations, accompanying family out of town, etc. **College visitations will be considered school business if authorized by the Administration in advance.**

4. ABSENT FROM CLASS – TRUANT

Truancy occurs when a student is absent from school/class without school consent. Such an absence will be considered unexcused and will result in disciplinary action by the Assistant Principal for Student Affairs.

5. SIGN-IN PROCEDURE

Any unaccompanied student arriving to school after 8:45 AM must report to the Tardy Booth. Students who are accompanied by parents will sign-in through the Main Office. A sign-in pass will be issued indicating excused/unexcused tardy or absence. It is the student's responsibility to show the sign-in pass to his/her teacher so that he/she can be marked accordingly. Only students accompanied by either a parent/guardian* or a doctor's note will be considered excused* (pending reason). **No phone calls will be accepted. Students may not have more than three sign-ins in a nine-week period.** Any additional sign-ins will require medical or other documentation or parent conference with an Assistant Principal for Student Affairs. **Student with excessive sign-ins will be subject to disciplinary action.**

6. SIGN-OUT PROCEDURE (PRE-APPROVED AND EMERGENCY)

Once students arrive on campus, they may not leave without permission from an Assistant Principal for Student Affairs. Students who become ill must sign-out through the clinic. If a parent needs to call regarding a student's sign-out, the parent must call the Student Affairs Office. Please do not call the attendance clerk or leave sign-out messages on the attendance line. **Parents whose children do not have a hang tag will have to go to the Main Office to sign their child out.** Only a student who drives to school with a current parking hang tag may leave without being accompanied by the parent or guardian signing him/her out. Student drivers must report to the Student Affairs Office prior to leaving campus. **Students may not walk off campus unaccompanied after signing out.** Signing out a student during his/her assigned lunch may result in a longer delay due to the ability to locate the student. **Students may not have more than three sign-outs in a nine-week period.** Any additional sign-outs will require medical or other documentation or parent conference with an Assistant Principal for Student Affairs. **Students with excessive sign-outs will be subject to disciplinary action.**

The following list are examples of what is acceptable regarding sign-ins and sign-outs:

SIGN-IN:

EXCUSED

- a. Illness/ Medical/Dental appointments (doctor's statement may be required)
- b. Automobile accident
- c. Deaths/funerals
- d. Emergency situations acceptable to Student Affairs Office
- e. Required court appearance (subpoena required)
- f. Established religious observance
- g. College Visitation: College visits by students will be considered an excused absence. School Business will be granted for college visits if a visit is required for admission and is documented on letterhead.

UNEXCUSED

1. Car problems (flat tire, no gas, car won't start, traffic, etc.)
2. Overslept
3. Returned for forgotten items (books, lunch, money, homework, projects, absentee notes etc.)
4. Missed the bus

SIGN-OUTS: (No sign-outs after 3:00 pm or 2:00 pm on Mondays)

EXCUSED

1. Medical/dental appointments (doctor's statement may be required)
2. Deaths/funerals
3. Emergency situations acceptable to Student Affairs Office
4. Court appearance (subpoena required)
5. Personal reasons acceptable to Student Affairs Office

UNEXCUSED

1. Forgotten items (books, lunch, money, homework, projects, admit etc.)
2. Violation of dress code (to obtain appropriate dress)
3. Non-educational appointments

8. ALTERING/FORGING DOCUMENTS

The altering or forging of parent notes, passes, or any other official school document will result in major disciplinary action which may include suspension from school. Additionally, students willfully giving false information to a school official or calling in to excuse his/her own absence are subject to major disciplinary action which may include suspension.

9. IDENTIFICATION CARDS

Student must have a Sickles I.D. in their possession while attending classes or any other school function. I.D. will be issued free to new students upon enrollment. Replacement cost for a lost or stolen I.D. is \$5.00 and can be purchased in the Gryphon Corner.

10. CLINIC/MEDICATION

For a student to be medically treated for illness and/or injury they MUST have a Parent/Guardian consent for school health services on file. This permission form will be sent home with the students on the first day.

- a. Medications that are labeled daily, twice a day or three times a day should be given at home. Medications that must be administered during school must be labeled with the exact time of day "i.e., 12:30".
- b. There are NO exemptions (other than religious) for required immunizations and physical exams.
- c. Students who are showing signs of communicable illness "i.e., fever >100, productive cough, sore throat, vomiting, diarrhea, etc." should not attend school in person.
- d. Please have several emergency contacts on file and have an emergency contact who can pick up your student within 30 minutes if you are unable to.
- e. We participate in the Healthy Student Program meaning that with proper paperwork turned in your student may receive basic over-the-counter medication while at school at no cost. The paperwork for this program will also be sent home with your student on the first day of school.

Please feel free to contact the clinic if you have any questions.

COMMON DISCIPLINARY CONSEQUENCES:

We will be adhering to the social distancing guidelines with respect to the following consequences:

- **Timeout** – Student will report to the In-School Suspension (ISS) room for one or multiple periods during the day, depending on which periods he/she has had behavior concerns.
- **Lunch Detention** – Student will report to the Lunch Detention room for his/her entire lunch period for one or multiple days. He/she will eat lunch in the detention room.
- **Work Detail** – Student will report to Work Detail after school from 3:35 – 4:35 pm (or 2:35 – 3:35 pm on Mondays). Student is monitored by a teacher while assisting with campus beautification and/or recycling program activities around the campus.
- **ISS (In-School Suspension)** – Student will report to the ISS room for one or multiple entire school days. The ISS room is monitored by teachers. Students are expected to obtain all assignments prior to attending ISS.
- **OSS (Out-of-School Suspension)** – Student is suspended out of school for one or multiple days depending on the offense. Students are unable to come to school or any school functions while suspended.
- **EPIC (Education, Prevention, and Intervention Center)** – Student is allowed to attend an alternative school setting while suspended out of school in order to complete classwork. If a student attends EPIC, he/she is considered present in school. Students are NOT allowed to attend any extracurricular events during the time they are assigned EPIC.
- **Saturday School** – Student may attend a Saturday School session on a pre-arranged date for three hours as an alternative to in- or out-of-school suspension based on the offense and discretion of the assistant principal. Saturday School consists of 1.5 hours of academic work as well as 1.5 hours of school beautification projects.



Student Guide To... The Most Common Rule Infractions



Dress Code

Pants must be secured at the waist; boys shirts must have sleeves. Jeans with rips/tears must not be higher than mid-thigh. No bare midriffs, crop tops, racer-back tops, spaghetti straps or less than 3-finger width tank tops, or see-through shirts. Garments with offensive language, drug/alcohol references, head coverings & bandanas shall not be worn. Masks shall be worn by all students at all times while on campus.

Consequences:

1st Offense—Change clothing/Conference with student
2nd Offense—Change clothing/Detention/Parent Contact
3rd Offense—Change clothing/Work Detail/Parent Contact
****If a student refuses to change his/her clothing during any violation, he/she will be sent directly to ISS.**

Tardies

Accumulate every 9 week grading period. Student is considered tardy if not in assigned classroom when the tardy bell rings. Tardy students report to the gym ticket window for all periods.

Consequences:

1st, 2nd & 3rd Tardy—Verbal Warning
4th Tardy—1 Day Lunch Detention/Parent Contact
5th Tardy—2 Days Lunch Detention/Parent Contact
6th Tardy—1 Day Work Detail/Parent Contact
7th Tardy—2 Days Work Detail/Parent Contact
****Tardies after 7 will result in increased consequences including possible Saturday School.**
****Students who do not attend assigned discipline will receive additional consequences.**
****Student drivers with 4 Tardies to 1st period will have their hang tag revoked for 2 weeks each additional tardy.**

Vaping/ Tobacco Products

Possession and/or use of any nicotine, oil based, or tobacco related product on campus is prohibited. Students violating this policy will be subject to a civil citation from the school deputy and Out of School Suspension. Civil citations will result in a suspension and/or denial of your driver's license.

1st Offense— Civil Citation and 1 Day OSS
2nd Offense— Civil Citation and 2 Days of OSS
3rd Offense— Civil Citation and 3– 5 Days of OSS

Sign-Ins/Outs

Students are only allowed 3 excused sign-ins/outs without an approved doctor's note per 9 week period, even with a parent/guardian. Students must sign-in at the tardy booth if unaccompanied by an adult. Students must sign-out with the Main Office prior to leaving campus.

Excessive Sign-In/Out Consequences:

4th Sign-In/Out—1 Day Lunch Detention/Parent Contact
5th Sign-In/Out—2 Days Lunch Detention/Parent Contact
6th Sign-In/Out—1 Day Work Detail/Parent Contact

****Students who do not sign-out with the Main Office prior to leaving campus will be considered leaving campus without permission (1 day Saturday School).**

**** Student drivers with 4 Unexcused Sign-Ins/outs will have their hang tag revoked for 2 weeks each additional sign-in/out.**

Skipping Class

Students must be in attendance to all classes or he/she will be considered skipping class.

Consequences:

1st Offense—1 Day of Work Detail/Parent Contact
2nd Offense—2 Days of Work Detail/Parent Contact
3rd Offense—1 Day of Saturday School/Parent Contact
Additional Offenses—2 Days of Saturday School, ISS or OSS
****If a student does not attend Work Detail or Saturday School he/she will receive ISS.**

Inappropriate Social Networking/Online Behavior

The inappropriate use of Facebook, Twitter, Instagram, Snapchat, or any other social networking site or app. to humiliate, discriminate, bully, or negatively reflect another student, the school, or faculty & staff through video, photo, text, or other correspondence that may affect the educational process.

Consequences will range from Saturday School to Out-of-School Suspension and could include a change of school placement depending on the severity of the behavior.


3. Once you have been assigned a locker, check to see if the combination works.

- **Be prepared to show: (1) valid driver's license; (2) vehicle registration; (3) class schedule (if OJT/FLVS/Dual student).**

- _____ 1. Parking hang tags MUST BE ATTACHED to the rearview mirror and visible through the front windshield. **HANG TAGS MUST BE DISPLAYED WHILE ON CAMPUS.** Failure to properly display a parking hang tag could result in the vehicle being towed from campus. All towing fees are the responsibility of the student and/or parent/registered owner.
- _____ 2. Vehicles should be parked in the student parking lot only. The parking spaces marked "reserved" (before the gate entrance into the student parking and the coaches' spots) are off limits. The faculty, handicapped, visitor, and bus ramp areas/spaces are also off limits. Only OJT and FLVS students can park in Lot B (before the gate entrance).
- _____ 3. Parking hang tags are NOT TRANSFERABLE. Students must not loan or sell their hang tag to another student. Duplication or forgery of hang tags will result in the loss of all parking privileges for the remainder of the year.
- _____ 4. The Student Parking Lot is OFF-LIMITS during the school day without written permission from an ADMINISTRATOR. Any student found in the parking lot without permission is subject to disciplinary consequences.
- _____ 5. **Standing around or sitting in a car is prohibited in the parking lot.** Students must report directly to the patio/classroom upon arrival to school and must leave the parking lot immediately after dismissal. Playing loud and/or obscene music is prohibited.
- _____ 6. If any vehicle information changes (make, model, etc.), it is the student's responsibility to update the Parking Application on file in Student Affairs.
- _____ 7. The speed limit on campus is **10 miles per hour.** Safe driving must be observed at all times, including wearing seatbelts when required by law. Students who are seen driving over curbs, cutting in front of other cars, driving in the wrong lane, etc. will have parking privileges revoked for 2 weeks.
- _____ 8. **Students must be clear of any school debt before purchasing a parking hang tag.**
- _____ 9. The cost to replace a damaged or lost parking hang tag is \$20.00.
- _____ 10. Student vehicles parked on campus are subject to search with probable cause. The school is not responsible for theft or damage to vehicles while parked on campus.
- _____ 11. The gate to the student parking lot is locked 10 minutes after the tardy bell of each period and re-opens at the end of each period. Parents/guardians must call Student Affairs to sign out drivers on campus.
- _____ 12. Out of School Suspensions and EPIC will result in the loss of parking privileges for the remainder of the year.
- _____ 13. **Students who accumulate 4 unexcused tardies to 1st period or 4 unexcused sign-ins/outs during a Quarter will have their parking hang tag revoked for two weeks along with the assigned disciplinary consequences for tardies.**
