REQUIREMENTS FOR REGISTRATION

Listed below are the requirements for registration at Alonso High School.

THIS INFORMATION IS REQUIRED OF ALL STUDENTS BEFORE ENROLLMENT

A. If student is coming from a Hillsborough County public school, you must have the following:

1. Verification of parent's address. This must be **TWO** of the following (**Affidavits are not Accepted**):
 - A. *Tax Receipt or validation of Homestead exemption (primary Source of verification)*
 - B. **Current** Electric Bill (**within a month**)
 - C. Warranty Deed or Lease agreement

B. If student is coming from a PUBLIC SCHOOL within Florida, you must have the following:

1. A report card or transcript from the last school attended.
2. Verification of parent's address. This must be **TWO** of the following (**Affidavits are not Accepted**):
 - A. Tax receipt or validation of homestead exemption (**primary source of verification**)
 - B. **Current** Electric Bill (**within a month**)
 - C. Warranty Deed or Lease agreement
4. Birth Certificate
5. Immunization records – showing proof of proper immunizations; including T.D. booster (every 5 years for Florida), second MMR, and Hep B series (HBV). ******MUST BE ON THE FLORIDA FORM******

C. If student is coming from a PUBLIC SCHOOL OUTSIDE Florida or from ANY PRIVATE SCHOOL, you must have the following:

1. A report card or transcript from the last school attended.
2. Physical examination from a private physician (must be within the last 12 months) or from the Hillsborough County Health Department. ******MUST BE ON THE FLORIDA FORM******
4. Verification of parent's address. This must be **TWO** of the following (**Affidavits are not Accepted**):
 - A. Tax receipt or validation of homestead exemption (**primary source of verification**)
 - B. **Current** Electric Bill (**within a month**)
 - C. Warranty Deed or Lease agreement
5. Birth Certificate
6. Immunization records – showing proof of proper immunizations; including T.D. booster (every 5 years for Florida), second MMR, and Hepatitis. B series (HBV). ******MUST BE ON THE FLORIDA FORM******

D. All students must reside with one parent or legal guardian. Proof of guardianship is a copy of court order appointing guardianship. (Powers of attorney are not accepted).

E. Students who are eighteen years or old and who have interrupted their Education will be referred to the Adult Education Program, as prescribed by the policies of the school board.

F. All students must attend the school in the district where their parents or legal guardians reside. Application for School Choice may be obtained on-line (sdhc.k12.fl.us). It must be filed with the Pupil Assignment Office, 901 E. Kennedy Blvd.
